**Decree of the Rector No. 3/2020,**

which regulates the fees connected with studies for the 2020/2021 academic year

## **Article 1**

### **Setting the base for calculating fees connected with studies**

- (1) Under Section 58 of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments to Other Acts (hereinafter the "Act"), as amended, and under Articles 20 and 21 of the Statutes of the Academy of Performing Arts in Prague (hereinafter the "Statutes"), fees connected with studies are derived from a so-called "base" in the sense of the provisions of Section 58(2) of the Act.
- (2) The base is announced by the Ministry of Education, Youth and Sports (hereinafter "MŠMT"). The base shall be valid for the academic year beginning in this calendar year.
- (3) The **base** for setting the fees connected with studies has been set by MŠMT for the academic year starting in 2020 in the letter File No. MSMT-2002/2017-1 dated 30 January 2020 in the amount of **CZK 4,393** (to wit: four thousand three hundred ninety-three Czech crowns).

## **Article 2**

### **Fees for actions connected with the admissions process**

- (1) **The fee for actions connected with the admissions process** pursuant to Section 58(1) of the Act shall amount to CZK 878 (eight hundred seventy-eight Czech crowns) for each submitted application.
- (2) The due date for the fee for actions connected with the admissions process is set as the deadline for submitting applications, or by the terms and conditions of the admissions proceeding.
- (3) Fees for actions connected with the admissions process shall be paid by means of a cashless transfer to the bank account of the Academy of Performing Arts in Prague (hereinafter "AMU"), account number 19-5373180297, bank code 0100.
- (4) Fees for actions connected with the admissions process shall constitute income of the main activity.
- (5) After paying the fee, the student or participant shall be required to present the payment receipt to the Department of Academic Affairs (Studijní oddělení) for inspection.

## **Article 3**

### **Fees for longer studies**

- (1) **The fee for longer studies** for individual Bachelor's and Master's programmes, pursuant to Section 58(3) of the Act and to Article 18 of the Statutes shall amount to **CZK 17,572** (seventeen thousand five hundred seventy-two Czech crowns) for each additional six months of studies or part thereof.
- (2) The fee for longer studies shall be due no less than 90 days from the date of issue of the Dean's decision on the assessment of the fee.
- (3) The fee for longer studies shall be paid by means of a cashless transfer to AMU's bank account, account number 19-5373180297, bank code 0100.
- (4) The fee for longer studies shall constitute income of the scholarship fund.
- (5) The Rector may reduce, waive or postpone the due date of the fee for longer studies, generally by recommendation of the Dean of the faculty in which the student is registered, in particular

with a view to the student's academic results and social situation, according to the principles stipulated in the Act and in AMU's internal regulations and norms, in particular Decree of the Rector No. 1/2019, on the rules regulating fees for longer studies.

#### **Article 4**

##### **Fees for studies in a foreign language**

- (1) Fees for studies in a programme of study realised in a foreign language pursuant to Section 58(4) of the Act shall be set pursuant to Article 20(5) of the Statutes.
- (2) The fee for studies in a programme of study realised in a foreign language shall be due in 2 instalments by the 15th day of the calendar month in which the given semester begins. Details shall be stipulated in the Agreement on a Foreign Student's Studies.
- (3) The fee for studies in a foreign language shall be paid by means of a cashless transfer to AMU's bank account, account number 19-5373180297, bank code 0100.
- (4) The fee for studies in a programme of study realised in a foreign language pursuant to Section 58(4) of the Act shall constitute income of the main activity.
- (5) After paying the fee for studies in a programme of study realised in a foreign language, the student shall be required to present the payment receipt to the Department of Academic Affairs (Studijní oddělení) for inspection.
- (6) The Rector may reduce, waive or postpone the due date of the fee for studies in a programme of study realised in a foreign language, generally by recommendation of the Dean of the faculty in which the student is registered, in particular with a view to the student's academic results and social situation, according to the principles stipulated in the Act and in AMU's internal regulations and norms.

#### **Article 5**

##### **Final provisions**

- (1) Decree of the Rector No. 2/2019 and Decree of the Rector No. 6/2019 are hereby rescinded.
- (2) With effect from the date of validity of this decree, Decree of the Rector No 3/2014, which sets the procedural rules of the subject councils for doctoral studies at AMU, is hereby rescinded.
- (3) This decree shall become valid and effective on 1 October 2020, unless stipulated otherwise.
